4. Adequate information on substances subject to restriction in food, obtained by experimental data or theoretical calculation about the level of their specific migration and - where appropriate - purity criteria in accordance with Directives 2008/60 / EC, 95/45 / EC and 2008 / 84 / EC to enable the user of these materials and articles comply with the relevant EU rules or - in their absence - national provisions applicable to food:

No dual use additives substances were used for the production of the products to which this declaration refers to.

Products meet the requirements of Directive 94/62 on packaging and packaging waste and heavy metal content and another amending directive. The sum of the concentrations of lead (Pb), cadmium (Cd), mercury (Hg) and hexavalent chromium (Cr VI) does not exceed 100 mg / kg.

No primary aromatic amines listed in Annex II of Regulation (EU) No 10/2011.

(i) Products made of PET foil are intended to come into contact with any type of food,

(ii) The products are intended for long-term storage at room temperature or below, including heating to 50 ° C for no longer than 2 hours.
